Brother Dave Nelson is putting on the Memorial Day Picnic on Sunday, May 25th. We are hoping for a good turnout.

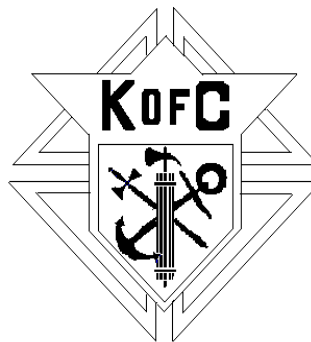
I would like to thank all those who continue to help support our bingo.
