## **Knights of Columbus Substance Abuse Awareness Poster Contest**

The Supreme Council has started a Substance Abuse Awareness Poster Contest as a way to get young people involved in promoting Substance Abuse awareness & deterrence. The contest involves students designing a poster promoting awareness in two topics; Alcohol Abuse & Awareness, or Drug Abuse & Awareness.

The contest is divided into two age groups, ages 8-11, and ages 12-14. This contest is a multi level competition. It begins at the council level. 1 Winner for each topic in each age group (4 total) then move onto a district level, then state level, and finally at the international level. Winners at each level will receive awards, with the potential of a \$250 prize to the top winner at the international.

The Rules of the Contest are as follows;

1. Posters must reflect either the theme of Alcohol Awareness & Abuse, or Drug Awareness & Abuse.
2. Each poster should be an original work (including concept, layout, slogan, and any visual images) of a single person
3. Posters must be 11x17 inches in size. If pastels, chalk or charcoal are used the poster must be laminated or covered with clear plastic. Posters may be in color or in black & white.

Myself along with the Grand Knight encourage all eligible youth to participate in this contest. The deadline for entries will be January 27th, with the judging to take place the following week. Anyone who has a child who is interested in participating, contact me at the following;
